## "A Patient in Coma Came Round through the Prayer!"

The 13<sup>th</sup> WCDN International Christian Medical Conference in Spain, Attended by People from 33 Countries

Based on medical data the World Christian Doctors Network (WCDN) has proven cases of healing through God the Creator's power. The 13th WCDN International Conference was held in Valencia, Spain on June 10-11, 2016.

More than 300 medical doctors and professionals from 33 countries including USA, Russia, the U.K., Italy, Poland, and Israel attended.

Since many people from many different countries joined, simultaneous interpretation service was offered in four languages: English, Spanish, Russian, and Italian. On the first day a local praise team opened the event with praise and worship. The Morning Devotion followed under the lead of Dr. José Garcíia. Then the participating countries were introduced, and welcome messages were delivered by Chairman of Spain's Organizing Committee, Dr. Juan Carlos Solan and by the President of WCDN, Dr. Gilbert Y. Chae and the ministry of Dr. Jaerock Lee, Founder of WCDN, was presented through DVD.

In the following presentations the diversity of the healing cases is shown: Post Spinal TB Paraplegia & Spinal Tumor-post op Paraplegia by Dr. Jayachandran Palsamy (India); Acute Encephalitis by Dr. Timothy Sng (Malaysia); Spine Fracture by Dr. Zipporah Ngumi (Kenya); Gallbladder Stone by Dr. Robert Wagner Navas (Colombia); Infertility by Dr. David Eu (Singapore); Radial Nerve Palsy by Dr. Gilbert Chae (Korea); and Posterolateral Knee Injury by Dr. Brian S. Yeo (Refer to pages 3 and 4).

Since God created the heavens, the earth, and all things including mankind, He can heal any kind of disease or infirmity. Dr. Timothy Sng from Malaysia presented the healing case of acute encephalitis. He said, "A woman was admitted to my hospital and fell into coma. I went to the previous conference held in Malaysia and attended the handkerchief healing meeting led by Rev. Heesun Lee. On behalf of the patient, I received Rev. Lee's prayer of the handkerchief on which Dr. Jaerock Lee had prayed (Acts 19:11-12). Then, the patient came around and recovered quickly. We experienced the space-and-time-transcending work."

The special speeches also caught many participants' attentions such as "Creation and Science" by Dr. Alvin J. Hwang (Korea), "Finding Harmony between the Scientific and Spiritual World Views" by Pastor Jose Victor Dugand (USA), and "Heaven" by Dr. Andre Gasiorowski (Israel). Spain's Organizing Committee gave a plaque of appreciation to Dr. Jaerock Lee, Founder of WCDN with their thankful hearts. The Crystal Singers, a performing team of Manmin Central Church, showed various kinds of performances such as singing in many languages, a fan dance, and Spanish traditional dance performances. The attendees were touched and gave glory to God with standing ovations. They said, "We could see the works of God occurring even today. We showed the authenticity of the Bible by attesting to the divine healing works through use of medical data. It was awesome and impressive."

WCDN is headquartered in South Korea, and it is a group of Christian medical doctors organized transcending denomination. They hold conferences annually, thereby promoting Christian doctors' communication and cooperation and working for the kingdom of God. In 2017, the next conference, the 14th conference, is to be held in Russia.

"But He was pierced through for our transgressions, He was crushed for our iniquities; the chastening for our well-being fell upon Him, and by His scourging we are healed" (Isaiah 53:5).

Jesus suffered from the crucifixion in the providence of God who wanted to save mankind, who had all become sinners. Then, what is the meaning in the providence in which Jesus was nailed through His hands and feet?

#### 1. The Reason Jesus Was Nailed through His Hands and Feet

Most forms of execution end in a relatively short amount of time without bringing about much pain upon the body. Crucifixion, however, inflicts an excruciating amount of pain for a long period of time. When both hands and feet of a person are nailed to a wooden cross, which is then erected perpendicular to the ground, all of his weight moves downward in his body and even greater pain is inflicted upon the very spots where the nails pierce. Furthermore, as the executioners avoid nailing vital parts of the body, the person bleeds continually and is subject to pain and suffering until the moment he breathes his last.

For what reason did Jesus have to be nailed through His hands and feet? It was to redeem man from all sins he committed and would commit with his hands and feet.

Mark 9:43-45 reads, "If your hand causes you to stumble, cut it off; it is better for you to enter life crippled, than, having your two hands, to go into hell, into the unquenchable fire, [where their worm does not die, and the fire is not quenched]. If your foot

causes you to stumble, cut it off; it is better for you to enter life lame, than, having your two feet, to be cast into hell." The sinless Jesus redeemed us from our sins we commit with our hands and feet by being nailed through His hands and feet and bleeding to death.

Therefore, anyone who has accepted Jesus as his Savior can receive forgiveness without cutting off his hands and feet when he repents and can even rid himself of all sins by the power of the Holy Spirit. In order to forgive our sins and prevent us from falling to the fires of Hell, Jesus subjected Himself to the brutal suffering on the cross.

Yet, among those who profess their faith in Jesus and claim to repent of their sins with their lips, many of them still live amidst sin. 1 John 1:6 tells us, "If we say that we have fellowship with Him and yet walk in the darkness, we lie and do not practice the truth." If you truly believe that Jesus was nailed through His hands and feet and suffered on the cross because of your sins, you could not sin ever again.

#### 2. Walk in the Light to Be Set Free from the Curse of the Law

The sinless Jesus was cursed on our behalf by dying on the wooden cross, and we who believe this have been forgiven of all our sins and have been set free from the curse of the law. Those who believe and have thus accepted Jesus as their Savior have been released from diseases, infirmities, poverty, and all other kinds of disasters.

Therefore, God's children who have accepted the Lord and live by God's Word are always under His watchful eyes. If trials and suffering come their way even if they live by God's Word, these trials are intended for blessing. James 1:12, "Blessed is a man who perseveres under trial; for once he has been approved, he will receive the crown of life which the Lord has promised to those who love Him." As said, overcoming the trials with thankfulness will bring forth blessings in both spirit and flesh.

What should you do if trials and sufferings come your way because you failed to live by God's Word? It is time for you to quickly repent and turn from your ways of the past. Once you destroy the wall of sin and pray by faith, trials and suffering have no choice but to be driven away. In some instances, you may face difficulties not because of your sinning but through mishaps. Even in such times, God will do His work according to your faith if you trust in Him. As Jesus was thus cursed on the cross, anyone can be forgiven of his sins by faith and set free from the curse of the law.

Does this mean our confessing, "Lord, I believe!" will warrant us unconditional forgiveness? As the Bible tells us in 1 John 1:7, "But if we walk in the Light as He Himself is in the Light, we have fellowship with one another, and the blood of Jesus His Son cleanses us from all sin," forgiveness of sins is conditional upon our 'walking in the Light.' Nowhere in the Bible do we find that we can still receive salvation despite sinning.

Jesus also tells us in Matthew 7:21, "Not everyone who says to Me, 'Lord, Lord,' will enter the kingdom of heaven, but he who does the will of My Father who is in heaven will enter." Thus, forgiveness will be given and perfect salvation fulfilled only when we accept Jesus as our Savior, repent of our sins, strive never to sin again, and walk in the Light.

#### 3. The Differences in the Biblical Accounts of What Was Spoken by the Two Robbers

When Jesus was crucified, many people gathered and were insulting and mocking Jesus. On either side of Jesus was a cross on which two robbers were being crucified. Concerning them we find in Matthew 27:44, "The robbers who had been crucified with Him were also insulting Him with the same words." Then from Luke 23:39-43, we find one of the robbers "hurling abuse" at Jesus and the other robber "rebuking him."

How can the difference in the recordings be explained? This was part of God's work so that readers

#### of the future generations could get a more vivid image of the event. Draw a picture in your mind: three crosses standing atop Golgotha, a large crowd gathered to witness the impending executions. There were Roman soldiers trying to fend off a flood of additional onlookers with spears and shields.

Under such rowdy circumstances, a person who was standing on one robber's side would have been able to hear clearly what was being said by the robber, but not so clearly the words of the other robber. In other words, the repentant robber's rebuking of the other robber who was insulting Jesus may sound as though the repentant robber was actually rebuking Jesus. Yet, the people standing by the repentant robber's side of Jesus could clearly hear the words of both robbers and Jesus and make accurate recording of the incident.

Of course, the almighty God is able to reveal to the writer of the Bible every detail that transpired. By allowing such differences in the recording, however, God has made it possible for people who read the Bible in the inspiration of the Holy Spirit to have a vivid picture of Jesus' crucifixion that is comparable to seeing a movie on a large screen in a well-equipped theater.

Therefore, when we come across parts of the Bible that are not in agreement with our ways of thinking, instead of judging them by fleshly thoughts and standards, we ought to first understand the spiritual significance in the inspiration of the Holy Spirit.

Dear brothers and sisters in Christ, now that you have learned the reason Jesus was nailed through His hands and feet, you should receive forgiveness of your sins by believing this. I pray in the name of the Lord that your hands and feet will be blessed messengers spreading the love of our Savior, and you will come to understand God's Word in the inspiration of the Holy Spirit, and enjoy all the authority and blessings to which you are entitled as a child of God.

## God's Great Healing Works Confirmed through Medical Data

On June 10-11, 2016, the 13th WCDN International Conference was held in Valencia, Spain. Here let's listen to the testimonies of the believers who experienced the power of God through the prayer of Dr. Jaerock Lee.

#### The Blessing of Conception; God Opened Her Womb

"Isaac prayed to the LORD on behalf of his wife, because she was barren; and the LORD answered him and Rebekah his wife conceived" (Genesis 25:21).

It is God the Creator that can open and close the womb of woman. If you suffer from infertility, when you destroy the wall of sins against God and receive the prayer of a powerful pastor, you can receive the blessing of conception.

#### Through the Prayer Transcending Space and Time

"...'Lord, I am not worthy for You to come under my roof, but just say the word, and my servant will be healed'...'Go; it shall be done for you as you have believed.' And the servant was healed that very moment" (Matthew 8:8-13).

#### Through the Handkerchief Prayer of Power

"God was performing extraordinary miracles by the hands of Paul, so that handkerchiefs or aprons were even carried from his body to the sick, and the diseases left them and the evil spirits went out" (Acts 19:11-12).



Elder Busam Kim had no child for seven years after he got married. He and his wife used every kind of possible medical treatment but nothing worked. Meantime, they were guided to Manmin Central Church and learned about the Word of God from Dr. Jaerock Lee. In January 2007, they received Dr. Lee's prayer for the blessing of conception. And they were able to have their adorable daughter in their bosom in November 2007.

Deacon Munhong Kim also tried every method medically since he and his wife had no child after six years of marriage. None of the methods worked. In October 1999, his wife received Dr. Lee's prayer and experienced the fire of the Holy Spirit coming into her head and her body. She got pregnant almost immediately and in August 2000, she gave birth to a healthy boy.





Pastor Soohee Yim had no child after 13 years of marriage. She tried to find the cause but it was not detected. She and her husband gave up having a child and thought about adopting a baby. In 2007, she was led to Manmin Central Church by her mother-in-law and witnessed many people conceiving babies through Dr. Lee's prayer. She received the prayer, but nothing happened because she did so without any faith. God waited for her and her husband until they were able to keep the peace between them and had faith. And finally when they received the prayer with faith, they received the blessing of conception and delivered a healthy son.

Brother Promod Kumar's wife had a problem with her thyroid which caused her to have several miscarriages. She asked a shaman for help and relied on Indian traditional medicine. All of it was of no use. In 2013, the couple was guided to Delhi Manmin Church in India. In July 2014, they sent their prayer request to Dr. Jaerock Lee in Korea with their picture. After they received his prayer transcending space and time, the wife got pregnant and delivered their first child after the 14 years of waiting.





Sister Sato Hiromi had no child although she had been married for several years, so she received medical treatments in fertility clinics. But nothing worked. In February 2013, she gave her picture and offerings to Pastor Miyako Dokkikuni who was to visit Korea and asked her to receive Dr. Jaerock Lee's prayer on her behalf. After she received the prayer transcending space and time in May 2013, she became pregnant. Finally, she gained a pretty daughter.

Brother John Babu had a problem; it was that he hadn't conceived a baby during the 4 years of his marriage. In 2008, he joined the electric and water-related works of Chennai Manmin Church, India. In the meantime, he heard about the testimonies of the church members who were experiencing miraculous works of God. He came to have hope. In December 2010, he attended the handkerchief healing meeting held in Chennai Manmin Church and received the handkerchief prayer (Acts 19:11-12). After the prayer, his wife became pregnant in February 2011. In the following November, she delivered a pretty daughter.





#### Sister Hortense Bandome got married in 1998 and had a daughter. But after she came down with rubella virus, she became unable to conceive again. In 2008, she registered in Kinshasa Manmin Church and attended Manmin Prayer Center President Boknim Lee's DR Congo Crusade in 2009. She received her prayer of the handkerchief (Acts 19:11-12) with her heart's desire of having babies. Then, she conceived a baby and delivered a son. Afterwards, she also had twin daughters. She now is the mother of four children.

#### The Re-creative Work of Knee Cartilage and Ligaments

#### Mr. Jaehong Park, age 48, South Korea



In his young days, he was a soccer prospect with success before his eyes. However, too much practice and repetitive knee injuries caused him to give up soccer. His knees were damaged more, and the pain and cramps in his legs often woke him up in the middle of night. He was in great pain as if someone twisted both sides of leg muscles and some people poked his knees with large needles.

In July 2014, he was guided to the handkerchief prayer meeting held in Chuncheon Manmin Church (Acts 19:11-12). Rev. Heesun Lee prayed for him with the handkerchief and he came to be able to squat bending his knees and stand up comfortably. His knees and his muscles used to make some cracking sound and some noise as if they were rupturing. But then, after the prayer, no such sound was heard. After the meeting, he ran down from the third floor to the lobby of the building. He had no pain at all. He still has no pain in his legs and knees.



Before the prayer, medial patellofemoral articulation was narrowed and the inner cartilage of patellar bone became thin. After the prayer, posterior cruciate ligament and the posterolateral complex and ligaments are healed.

Before the prayer, there was diffuse brain edema (upper), but after the prayer it was gone (lower).




#### He Was Paralyzed Due to Spinal Tuberculosis But Now He Is Healthy Enough to Drive!



Gallstone Was Removed by the Power of God




#### Ms. Maria Macuado, age 22, Peru


Mr. BanwariLal, age 47, India

In September 2014, she had acute abdominal pain and it lasted for several months. She had a medical test done and her doctor said she had gallbladder stone that was 16mm in size. She asked her pastor of Peru Manmin Church to pray for her with the handkerchief (Acts 19:11-12). After the prayer, she had no more pain and did not feel nauseated anymore.

In January 2015, however, the doctor said the stone became bigger, 18.2mm in size when she took another ultrasound. So, she started to repent of all the bad thoughts and feelings that she had kept during her past life. Then, she saw her Senior Pastor Dr. Jaerock Lee in her dream. He prayed for her with his hand on her sick part.

To her surprise, the following ultrasound showed that there was no gallbladder stone and she was completely normal.





Gallstone, 18.2mm in size disappeared.

#### His Spinal Fracture Was Healed through the Handkerchief Prayer

On March 23, 2015, he was working on the roof of the four-meter-high structure. Suddenly, some wood in the structure broke and he fell to the ground. He had so severe pain in his back that he could not move and could barely even breathe. His X-ray scan revealed that his backbone was fractured. He needed surgery.

On the following day, he received Nairobi Manmin Church's Bishop Dr. Myeongho Cheong's prayer of handkerchief (Acts 19:11-12). He felt a sense of feeling in his paralyzed legs and waist. The pain in his legs was disappearing little by little. He could move them. On March 31, he checked out of the hospital with faith. The next day, after he received Dr. Cheong's prayer again, he was given strength and sat up from his bed, stood up, and walked by himself!

He recovered quickly, and on April 23 he returned to his work as normal.
